In accordance with Section 373 of the City Charter, enclosed for your approval are the First Amendment to Contracts [i] DA-5131 with CMTS, LLC; [ii] DA-5132 with Lea+Elliot, Inc.; [iii] DA-5134 with Jacobsen I Daniels Associates, LLC; and [iv] DA-5135 with Parsons Transportation Group Inc. which was approved at the April 5, 2018 meeting of the Board of Airport Commissioners. There is no impact to the General Fund.
